Shipping Policy: Approximately 95% of our incoming (from customers) and outgoing (to distributors for drop ship) orders go through EDI systems. This allows us to process the vast majority of our customer's orders and send them to our distributors in under 90 minutes. More than half of the orders that are received before 1:00pm Mountain Time ship the same day. We also ship from more than 15 distribution centers (depending on product line). By shipping from the closest possible distribution center, we deliver most orders within 2 business days.

Return Policy: Government Customers can return any unopened (manufacturer seal not broken), unused "like new", unmarked items in the original packaging purchased from Access Products, Inc. dba Imaging Systems (API) within 30-days of the purchase date. API will provide a full refund, less any applicable restocking fee, for such item. Defective items may be returned for exchange up to 1-year from the date of purchase.

Access Products, Inc. will assess on a standard base manufacturer product, without customization, a 10% restocking fee and return freight/shipping fee. Any customized, specialized, or special-order item will have a 15% restocking fee per OEM. Any Fees associated with the return will come out of the credit.

RCTO or CTO (Retail Configure to Order or Configure to Order Items)

Once a RCTO/CTO item order has been placed this order <u>cannot</u> be cancelled.

<u>No returns</u> will be considered for RCTO/CTO Laptop and Desktop Computers under SIN 33411, those items are included at the end of this document.

Estimated Ship Time comes from the OEM and does NOT include transit time, general ARO expected is 45 days. OEM does not provide return shipping labels for RMAs as a result of a purchasing error, customer will be responsible for the return freight cost(s).

Restocking Fees: API will assess a restocking fee of 10% of the item cost or the entire order (if applicable) due to customer ordering errors or returns due to printers no longer in use at their facility. API can supply return labels IF needed, the cost of the label will be subtracted from the return total. No restocking fees are assessed when the item is returned due to a nonconforming item or shipping error.
